ARRANGEMENT FEE 193€/person, including

- Event organization and management
- **Tournament office at Hotel Holiday Club Vierumäki** – like DNHL 2018
- Gift for participants
- Welcome party on June 9th at Hotel Holiday Club Vierumäki, light buffet, drink coupon, LIVE music
- Final Night on June 11th at Hotel Holiday Club Vierumäki, three course dinner, 2 drinks coupon, LIVE music

DATES, DEADLINES AND REGISTRATION

Make your registration for DNHL2022 by sending email ville.hautala@vierumakigolf.fi. Please give us company name, address, email address, phone number and contact person. Then let us know how many people you want to register the event. Registration **dead line is 31st of January 2022**. By that date, all participants must be notified!

Arrangement fees 193€/person will be invoiced by Vierumäki Golf Club Ltd per company/hospital after that dead line. Please give us full invoicing information; Company name, address, email address, phone number, contact person name. You will receive two invoice 50€ + 149€/person

- 50€/person → The due date of the invoice is January 31, 2022 - *NO REFUND FROM THIS PAYMENT AT ALL !*
- 143€/person → The due date of the invoice is March 31, 2022.

Example for registration

If you want to register for example 50 person to DNHL

- Send an email ville.hautala@vierumakigolf.fi, tell your full contact and invoicing information and tell that you want to register 50 person DNHL 2022. Dead line 31st of January 2022
- Vierumäki Golf Ltd send you invoice by email and you have to pay 50 person x 50€ = 2 500€. The due date of the invoice is January 31, 2022
- Vierumäki Golf Ltd send you another invoice by email and you have to pay 50 person x 149€ = 7 450€. The due date of the invoice is March 31, 2022
- If you have for example 5 cancellations, then you need to pay 45 x 143€ = 6 435€

Guidelines for refund of registration fees (arrangement fee 193€)

To secure both organizer and participating club, the following applies:

- The organizer has right to retain first payment 50€ per participant (dead line 31st of January 2022)
- When a final registration and payment (143€ per participant) is made (31st of March 2022) the organizer, up to 21 days before the event (18th of May 2022), organizer has the right to retain 15€ per participant that is withdrawing
- If cancellations are given in the period 21 days to 7 days before the event (19th of May 2022 - 2nd of June 2022), the organizer has right to retain 75% of the costs 108€ per person
- If cancellations are given after 2nd of June, the organizer has right to retain the entire cost - no refund
